PROPOSAL TO MAKE CHANGES TO THE CONSTITUTION OF THE ASSOCIATION FOR SUPERVISION AND CURRICULUM DEVELOPMENT (SINGAPORE) UEN: S89SS0105L

Notice is hereby given pursuant to Section 14 of the Constitution of the Association of Supervision and Curriculum Development (Singapore) that the following Resolution be tabled for approval.

Section 14 of the Constitution states that

- 14.1 Amendments or additions/deletions to the Constitution shall be made at the Annual General Meeting or at an Extraordinary General Meeting called for the purpose.
- 14.2 Any amendment or addition/deletion to the Constitution shall require the support of at least two-thirds of the voting members present at the Annual General Meeting or at the Extraordinary General Meeting called for the purpose.

Two changes to the Constitution are proposed:

1. SECTION 5: MEMBERSHIPS

Add the following in relation to transfers and revocation of memberships.

- 5.5 All categories of Memberships are not transferable or assignable.
- 5.6 Memberships may be revoked by a resolution of the Executive Council if the Member is convicted of a felony or behaves in a manner inconsistent with the principles and purposes of the association

2. SECTION 9: MEETINGS, Sub-section 9.2: Supreme Authority and Annual General Meetings

Item 9.2.2: To change the word "March" to "May" in relation to changing the date of AGM from March to May of each year. The new Item is as follows:

9.2.2 The Association shall hold an Annual General Meeting by May of each year.

Any objections to this proposal may be submitted at any time up until or during the Annual General Meeting on 29 March 2019.



- 1.2 The 14th Executive Council would continue their service until 30 June 2019. The 15th Executive Council will assume office with effect from 1 July 2018 to 30 June 2020.
- 1.3 Dr Ang Wai Hoong and Mrs Lysia Kee are Advisors to the new Council.
- 1.4 Ms Koshu Lulla continued to serve as the Secretariat Administrator of ASCD (Singapore).

2. HONARARY AUDITORS

3. MEMBERSHIP

Membership in ASCD (Singapore) comprises mainly MOE HQ officials, school leaders, teachers and allied educators. As of 31 Dec 2018, there were a total of 476 members:

- i) 193 Life Members
- ii) 255 Ordinary Members
- iii) 28 Institutional Members

4. ACTIVITIES AND EVENTS

4.1 The 29th Annual General Meeting (AGM)

The AGM was held on 26 March 2018 at the MOE Heritage Centre, 402 Commonwealth Drive, Singapore 149599. The meeting was called to order at 3.30 pm by Mrs Lysia Kee, the Mistress of Ceremonies. 20 members were present. Members who attended the AGM were given a book of various titles.

ii) As there was no quorum, the meeting was adjourned for a reception followed by a Talk by Dr Peter Mack on "Rising After a Fall: Developing Mental Resilience in Adolescents."

The AGM proper resumed after the talk

Ms Yeo Hong Mui delivered her President's address. She thanked the ASCD 14th Executive Council and members for the work done within our resource constraints. She encouraged us to continue to provide quality professional development to educators. She spoke about the types of professional development opportunities that we could bring to our educators and ASCD Singapore should continue to play an important role to help educators.

As a professional association, Ms Yeo asked us to think how we could reach out to our members and what we could do for them. She acknowledged the work of our Literature Project and how we had added value to our local schools. While this might not take on a role similar to that of ASCD International's promotion of advocacy, she alluded to this as a possible avenue for us to reach out to more schools.

Ms Yeo also spoke on how we could continue our effort of sustained recruitment and membership retention. She thanked all for their support, in particular, the current Council, internal auditors and Ms Koshu for their contributions.

Ms Ek Soo Ben went through the Minutes of the 28th Annual general Meeting. The acceptance of the minutes was proposed by Dr Cheah Yin Mee and seconded by Mrs Soo Kim Bee.

4.2 Professional Development Programmes

ASCD (Singapore) engaged a variety of local and overseas trainers/facilitators in 2018 to provide professional development opportunities for School Leaders, School Staff Developers, teachers and allied educators. These are summarised in the table below:

4.3 Singapore Literature Project

- i) The objective of ASCD's Singapore Literature Project is to enhance our partnership with schools to motivate more students to read and to get familiar with Singapore Literature. This Project is a community project in partnership with Epigram Books. Epigram Books help us source for suitable books and get authors to visit the schools selected for this project.
- ii) The Singapore Literature Project continued its outreach efforts in 2018. The Project was successfully carried out with the following schools:
 - a. Queensway Secondary School
 - b. Queenstown Primary School
 - c. North Vista Primary School
 - d. Lakeside Primary School
 - e. Ngee Ann Primary School
- iii) As with previous years, the critical success factors for the Literature Project had been the enthusiasm of the teachers, the interactivity level between the authors and the students, the repertoire of engagement strategies used and the commitment from Epigram Books (EB).
- iv) The ASCD's Singapore Literature Project Sub-Committee will continue to identify schools which will benefit from this programme and strengthen its partnership with Epigram Books.

4.4 Quick Reference Guide (QRG) Project

i) ASCD (Singapore) aims to produce lesson plans for trainers based on selected ASCD QRGs. A Project Consultant, Ms Tang Swee Noi, had been approached to develop Workshop Lesson Plans on selected ASCD QRGs. These lesson plans would localise strategies to the Singapore context and provide teachers with hands-on practice with the identified strategies. Two plans had been completed, one for primary schools and one for secondary schools. Moving on, Ms Tang would conduct workshops based on the lesson plans and the QRGs for teacher members in April. These workshops are free for members. The QRG selected is on Questioning Strategies to activate student learning.

5 PUBLIC COMMUNICATIONS

5.1 ASCD (Singapore) Website

i) The ASCD (Singapore) website continued to be the platform providing information on ASCD programmes and updates to ASCD (Singapore) members and the public at large. Work is in progress for a refreshed website and a relaunch is scheduled for 2019.

5.2 Facebook

Interesting news and links to educational websites and articles continued to be added to the Facebook.
 This site which was managed regularly, had seen more activity. Visitorship has also improved.

6 ASCD (SINGAPORE)'s SPONSORSHIP

i) ASCD (Singapore) would continue to recognise our teachers' outstanding professional achievements at the National Institute of Education. ASCD (Singapore) would continue to sponsor gold medal awards and the "Best Capstone Project Book Prize" for the MEd C& T programme's top graduate students for the next four years. ASCD(Singapore) and the Med C & T Programme Office had also explored various means of collaboration for the future.
